

Stall Registration

This event is all about creating awareness for fast fashion and having the opportunity to sell and make a profit on your unwanted clothing and accessories.

\$10 registration fee- Includes your stall space and Public Liability Insurance

Terms and Conditions

1. **Stall Size** – Each stall area is approx 2m x 2m in size, please ensure that your stall set up fits within this space. Your area will be designated to you on arrival and will be depend on your set up. We will have event staff on the day making sure stalls are set up accordingly and there is enough room in between stalls holders for people to walk through.
2. **What can you bring for your stall set up** – **NO Gazebos** allowed however you can bring a umbrella, fold out table up to 1.8m in size, clothing rack, suitcase or mat, foldout chair to sit on as long as everything fits within your 2m x 2m area. Please note that the event stall space will be a combination of the pathway, grass areas and road areas.
3. **Cash till / Bank details**– collection of funds is the responsibility of the individual, please bring your own cash till with change or bank transfers can also be done on the day. Instant bank transfers such as PayID and Osko are fast easy ways to transfer funds on the day.
4. **Outdoor event** - Please remember this is an outdoor event so it is the responsibility of individuals to ensure they have appropriate sun protection including, hat, umbrella, sunscreen and water.
5. **What can you bring to sell** – Items that can be brought to sell include anything in your wardrobe.
 - Second hand clothing - Adult size 6 and up only (No baby and children's clothes permitted under public liability)
 - Bric-a-brac (home décor, vases, porcelain figurines, painted frames, vintage items etc)
 - Accessories (bags, shoes, belts, jewellery, hats)
 - Books, comics, magazines, dvds etc
 - Small decor potted plants

(see public Liability list below for all items that aren't covered under your public liability insurance)

6. **Arrivals and Departures-** On time arrival is essential, please make sure you arrive before 8.30am. All Wardrobe Holders must have their names ticked off by the advertised start time of the event. **Bump in will open 1.5 hours before the event at 7.00am.** Please give us a call and let us know you're running late. No Wardrobe Holders are to start packing up before the advertised closing time of the event of 1.00pm, please make sure you're able to commit to the end of the event time of 1.00pm unless sold out prior.
7. **Parking for Wardrobe Stall Holders –** Stall holder parking is located at 18 Carol Avenue & 1-7 Carol Avenue. If parking is full there is plenty of street parking located around the park. See below map.



8. **Logan City Council / Springwood Wardrobe Rummage takes no responsibility** for the safe keeping of personal property of stallholders or rummagers while at the event. The security of your takings, goods and personal items is your own responsibility.
9. **Logan City Council Workplace Health and Safety encourages safe workplace practices** when it comes to the handling of heavy equipment, particularly your suitcases, tables or clothes racks please remember your own safety when carrying your equipment and ask for assistance if needed. Logan City Council is not liable for injury caused by the incorrect carrying of equipment.
10. **There will be a NO Refund policy.** This is currently a once off event and there will be no refunds for stall fees unless the event is cancelled by a covid or extreme weather-related

circumstances. If you do not agree with this policy, then please think carefully before you purchase your ticket online.

11. **Donate left over items to the local op shops** – We will have some local ops shops participating in the event so if you have left over items you no longer want to keep, you do have the option to support local and donate to these local op shops.
12. **Covid-19 Safe Practices.** All stall holders must adhere to Covid-19 restrictions and measures, including social distancing. Event staff will do everything we can to monitor and manage the flow of traffic throughout the event. It is the stall holders responsibility to ensure good personal hygiene and social distancing within their stall. Please be responsible and sensible, do not come to the market if you are unwell, bring your own hand sanitiser, wash your hands regularly and notify our staff if there are any issues on the day.

Public Liability

Please see below the items that are **NOT** covered by your public liability insurance.

- **No Baby/Infant clothing/children's clothing (Size 6 adult & up only)**
- Goods imported by you
- Jumping castles, inflatable slides, trampolines, amusement rides
- Live animals
- Child minding activities
- Photo booths
- Toys
- Tobacco, E-cigarettes, electronic vaping devices, electronic nicotine delivery systems or similar smoking apparatus
- Sale of alcohol
- Amusement rides/devices – mechanical, powered or animal
- Bicycles, Skateboards, in line skates, roller skates, scooters and associated protective equipment
- Inflatable pools, life jackets, floating devices and other floating aids;
- Protective or safety equipment and/or clothing, eyewear and life preservation products
- Second hand electrical items & tools
- Automotive parts/accessories of any nature (including motorcycles)
- Sporting goods/equipment

- Swords, Spears, Bows, Crossbows, Firearms, ammunition or weapons of any kind
- Knives, not including chef/kitchen knives or garden pruning equipment
- Fireworks, pyrotechnics or explosives
- Sale of flammable, dangerous and/or hazardous chemicals, petrochemicals
- Pool chemicals and flammable liquids with a flash point below 23°C
- Sale of animals; Sale of animal feed, pet food or pet food supplements. Not including pet treats for domestic animals
- Vaporisers and humidifiers
- Treatment risks including massage, acupuncture, chiropractic treatment and natural therapies
- Nutraceuticals or cosmetics
- Any medical device or alternative therapy medical device including any massage device
- Detergents and/or soaps (including natural) manufactured by Insured
- Candles of any description and including the burning or heating by flame of oils/essences but excluding incense sticks
- Vitamins, minerals, herbals and other health supplements (other than food)
- Children's toys, Children's cubby houses
- Children' swings, slides, playground equipment or climbing equipment
